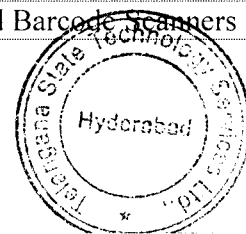

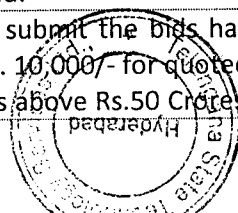

1. Bids should be submitted online on e-procurement portal "e-procurement.telangana.gov.in"
2. The Bidder should submit their technical and financial bids on e-procurement website and upload all the required formats, brochures and documents as mentioned in the tender document
3. The Bidder must be a company/firm registered under Companies Act, 1956/Sales/Service Tax Act and in the business of Barcode Printers and Barcode Scanners for the last 3years.(documentary proof shall be submitted)
4. The Bidder shall submit valid Sales/Service Tax Registration, PAN/TIN. Submit the copies of IT returns filed for the years 2014-15 to 2016-17
5. The Bidder shall have at least 5 Technically competent Engineers / Technicians on rolls, to undertake the Barcode Printers and Barcode Scanners installations.(documentary proof shall be enclosed to the Technical Bid)
6. The Bidder should have delivered and installed/commissioned minimum of 100 nos. of Barcode Printers and Barcode Scanners during last **Three financial years**(documentary proof such as PO, invoices and Satisfactory Performance Reports shall be enclosed to the Technical Bid)
7. The bidder should have an average annual financial turnover of Rs.50 Lakhs or above during last 3 financial years(2015-16, 2016-17 & 2017-18)
8. The bidder should submit/give declaration stating that they are not debarred/blacklisted by any State Government, central Government, Central & State Govt. Undertakings/enterprises/Organizations and by any other Quasi Government bodies/Organizations, World Bank or any major Enterprise/Organization in India for non-satisfactory performance, corrupt & Fraudulent or any other unethical business practices. Further stating/declaring that no cases pending against the firm/organization either in Government(State or Union) for involvement in cases for supply of sub-standard goods/material or track record of supply of inferior quality or no enquiries on past supplies are being conducted or underway.
9. Any deviations in format may make the quotation liable for rejection.
10. Bid shall be valid at least for a period of 180 days from the date of opening.
11. The unit price and total price shall be mentioned separately exclusive of taxes and inclusive of taxes but in both cases inclusive of installation and outstation charges if any.
12. **The Bidder should submit EMD for Rs.25,000/- along with Technical Bid in the form of D.D. in favor of the Managing Director, TSTSL, payable at Hyderabad. Bids without adequate EMD shall be summarily rejected.**
13. If optional bids are to be submitted, then separate EMD, Authorization, Technical literature etc., should be submitted with every optional bid and it is treated as separate bid for evaluation as per terms of Tender.
14. The EMD should be valid at least for a period of 90 days from the date of submission of bids.
15. i) Bidders must submit details of EMD value and date of validity along with their technical bid failing which the bid will be treated as non-responsive and is liable for rejection.  
ii) EMD will be returned to the Bidders after finalization of the tender.
16. The Brand/s quoted for the present tender should be internationally acclaimed manufacturer/s.
17. The Manufacturer/OEM should have full-fledged offices/service centers across India and at least one service center in Hyderabad. (Documentary proof shall be enclosed to the Technical Bid)
18. The OEM/Distributor shall be ISO 9001:2008 and the Barcode Printers and Barcode Scanners being offered.

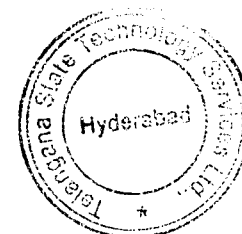


19	If the Bidder is not the Original Equipment Manufacturer, then the Bidder should submit Manufacturer Authorization Form from the Original Equipment Manufacturer / Sole Distributor specific to the present tender.
20	Managing Director, TSTS reserves the right to accept or reject any or all the bids without assigning any reasons thereof and to add, modify or delete any of the terms & conditions without any notice.
21	Managing Director, TSTS reserves the right to modify the technical specifications including Quantity at any time during the process of finalization of tender
22	Variation in quantities: +/-25% of indicative quantity. Individual Orders will be placed on actual requirements received during the bid validity period
23	Conditional bids are not acceptable and such bids are liable for rejection.
24	Original Equipment Manufacturer shall have Service Centers across India and at least one Service Center in Telangana State. The Service center of Original Equipment Manufacturer or Bidder shall maintain minimum stock/sparer's availability as on bid calling date. Details of the service centers and service personal shall be enclosed to the Technical Bid.
25	The Bidder should submit an undertaking letter on their company letter head stating that they have Technical knowledge in Supply, Installation, Operation and Maintenance of Barcode Printers and Barcode Scanners and accessories being proposed in the present tender.
26	It is the primary responsibility of Successful bidder for delivery, successful installation and also for imparting training to the end user on usage of the Barcode Printers and Barcode Scanners supplied.
27	The Successful Bidder/s should submit Service Level Agreement (SLA) on the Non judicial stamped paper along with Performance Bank Guarantee stating that the reported problems relating to Barcode Printers and Barcode Scanners will be attended in 24 hours and the same will be rectified within 48 hours.

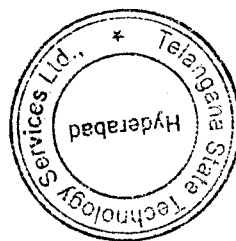

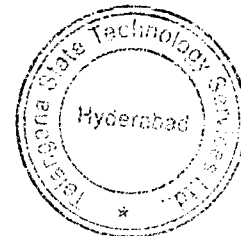


### Manufacturer Authorization Form

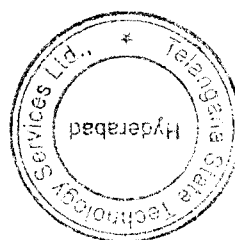

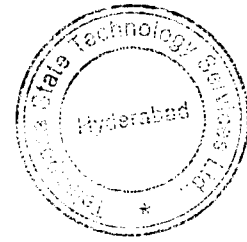
