SECOND PART.

WHEREAS

1. TSTS Limited (TSTS) is a Company owned by Government of Telangana and TSTS has the mandate from Government of Telangana (GoTS) for offering various information, interactive and payment services to the general public. TSTS intends to offer its services through its portal www.tsts.telangana.gov.in or any other website as it may so decide in future.
2. TSTS previously when proposed to engage/appoint Franchisee who would offer its Services to citizens through designated centers, the Franchisee of the II Part agreed and accepted the appointment on the terms and conditions and that both TSTS & Franchisee, entered into the "Agreement for Engagement of Franchisee for Services Required Under this Agreement", on ___-___-2016, which ended up by ___-___-2017.
3. The Franchisee having performed their services for the entire period of the Previous Agreement, satisfying its terms and conditions, now came forward and requested the TSTS, to extend the agreement by way of Renewal. TSTS having considered the case and that as per Clause No.5 of the Original Franchisee Agreement dt. ___-___-2016, the said agreement may be renewed by TSTS, after satisfying with the performance of the Franchisee.
4. Considering the request and satisfying performance of the Franchisee, the Original Agreement is renewed further, subject to the following:
 - (i) The Agreement for Engagement of Franchisee, dt. ___-___-2016, is hereby further Renewed for a further period of one year, i.e., commencing from ___-___-2017 to ___-___-2018.
 - (ii) The terms and conditions of the original Franchisee Agreement dt. ___-___-2016, are strictly applicable along with the terms and conditions mentioned in the present Renewal Agreement.
 - (iii) Security Deposit and other AMC Chargers payable by FRANCHISEE will be as per TSTS Policy. The Change in the Deposit and AMC Charges are as follows:

(iv) Considering the revised security deposit amount, the difference amount of Rs. 10,000/-, refundable to the Franchisee will be adjusted to the Revised AMC amount of Rs. 5000/- and the balance amount of Rs. 5000/- will be given as manual Top-up to the wallet of Franchisee. After the adjustments mentioned, the refundable security deposit is Rs.10,000/- and non-refundable AMC amount is Rs.5000/-, for the agreement period.

5. Therefore with all the above conditions in addition to the Franchisee Agreement dt. ___-___-2016, the present Renewal Agreement comes into existence.
